

List of Heat Pump Water Heater Incentive Programs

All of these programs support the installation of electric Heat Pump Water Heaters (HPWHs) to replace gas water heaters in existing buildings. They apply to single family homes, and some may also apply to single units in multifamily buildings. Please visit the program websites for more details and contact information. Projects that meet the eligibility requirements for multiple BayREN/CCA-funded program can be layered for a larger incentive unless marked otherwise.
